**Speaking of squash, I planted heirloom, uncoated, pure white squash seeds on June 11, 2015. On June 16, 2015 this metallic aquamarine squash seed comes to the surface. What would cause a seed to do this?**

## Rose Damage



**The new roses on this bush hit during an herbicide and high temperature event. The roses dried paper-dry in 1-day, as did all tomato flowers (pollinated or not)**

## Soil Microbe Damage
